The **International Master in Anti-Corruption Compliance and Collective Action** (IMACC) is:


- the first master's programme specially designed for anti-corruption compliance and collective action practitioners involved with the business sector

STRUCTURE

The IMACC is a two-year programme consisting of six modules and a final project or thesis. There is also an optional pre-master's course.

Each module has an intensive in-class phase (seven or ten days), allowing for maximum learning opportunities within a condensed period of time. Classes take place approximately every three months at the IACA campus in Laxenburg, Austria (Vienna area) and possibly other locations worldwide.
