## Guidelines Voluntary Financial Pledges: Explanatory Note

IACA promotes the prevention of and the fight against corruption through education, training and research, and by fostering international cooperation and networking opportunities. Its activities are mainly financed through voluntary contributions. In reiterating the need for reliable budgetary planning and allocation of resources, IACA kindly calls on all Parties and Signatories for shared financial ownership. IACA also appeals to other potential donors to contribute to its cause.

Particularly owing to the fact that IACA is in the build-up phase, it is dependent on stable finances and reliable resources in order to continue developing successfully and effectively maintain its operational work and other activities, such as strengthening research capacities and faculty.

In this context, IACA invites Parties and Signatories, as well as other stakeholders, to use the 3<sup>rd</sup> session of the Assembly of Parties from 19 to 21 November 2014, which marks a milestone in the evolution of the organization, for pledging financial contributions. **The envisaged high-level/ministerial segment on 19 November 2014 will especially allow for high visibility, positive political exposure, and enhanced commitment.**

### ***What should a financial pledge be about?***

According to Regulation 10 paragraph 1 of the *Financial Framework of the International Anti-Corruption Academy*, voluntary contributions shall **preferably** include contributions to the **general budget** of the Academy.

### **Examples of pledges:**
