# LEGAL INCENTIVES FOR CORPORATE INTEGRITY TRAINING APPLY NOW

The private sector has long been a driver for change, advancing corporate integrity reforms that are reshaping the global anti-corruption landscape.

Our Legal Incentives for Corporate Integrity Training, taking place from 4 to 6 May, has been developed to facilitate private actors' anti-corruption efforts as well as their compliance with the 10<sup>th</sup> Principle of the United Nations Global Contact. The three-day programme aims to strengthen corporate integrity and cooperation through legal incentives and sanctions, both within organizations and in their competitive work environment, as well as to promote an atmosphere of self-reporting.

The participant target group includes anti-corruption experts, business and government executives, leaders of civil society organizations, and academics with a minimum of three years of relevant work experience. Tuition fee waivers will be offered to participants from Least Developed Countries on a competitive basis.

# SUMMER ACADEMY APPLY NOW

We are now accepting applications for the fifth annual Summer Academy, taking place from 2 to 11 July.

The Summer Academy is an intensive, ten-day programme designed for professionals looking to consolidate their experience and enlarge their



competences to better counter corruption. Developed against an interdisciplinary background, the programme offers a series of courses, roundtables, and workshops that explore current anti-corruption debates and policies. Every year, 70 students from around the world take part.

Admission is open to candidates with a minimum of five years of relevant work experience in the private or public sector, international or non-governmental organizations. Media representatives, civil society, students, and researchers in areas related to anticorruption are also encouraged to apply.

Tuition fees are subsidized by the Siemens Integrity Initiative and participants from Least Developed Counties are eligible for full scholarships.

# BEST OF LUIS MORENO OCAMPO REGISTRATIONS OPEN SOON

The latest in the series of our "Best of" seminars will be held on 8 and 9 July. Luis Moreno Ocampo, the first Prosecutor of the International Criminal Court (ICC) and visiting professor at Harvard and Yale, will be on campus to share the "best of" his pioneering work in corruption investigations. Over

two days, he will discuss case studies and simulations on grand corruption and ethics, the functioning of corrupt networks, the role of international organizations, and the use of legal frameworks in controlling international corruption problems.


During Mr. Ocampo's term in office, the ICC was involved in some the most serious crises of the 21<sup>st</sup> century, including Afghanistan, Iraq, and Libya. Previously, he played a crucial role during the transition to democracy in Argentina, as the Deputy Prosecutor in the "Junta trial" in 1985 and the Prosecutor in the trial against a military rebellion in 1991.

Registrations for the Best of Luis Moreno Ocampo will open on 3 March. The five-day Anti-Corruption in Local Governance Training will start on 13 July, the Monday of the subsequent week.

# ANTI-CORRUPTION IN LOCAL GOVERNANCE TRAINING THE 2015 EDITION

The power of local governance is that small changes directly impact people's lives, their education, health services, and road infrastructure.

Our Anti-Corruption in Local Governance training is a five-day programme focusing on local governance and city-level corruption, and aiming to strengthen the skills of mayors, local politicians, regional government administrators, municipal administrators, ombudsman persons, and governance experts from development organizations. The training will provide participants with an in-depth understanding of the various types and mechanisms of corruption in local governance, such as procurement and licensing fraud, political interference, abuse of assets, nepotism, and undue influence, as well as tools to prevent it.

# MASTER IN ANTI-CORRUPTION STUDIES COMING THIS FALL

The Master in Anti-Corruption Studies (MACS) programme offers a post-graduate experience for working professionals that excels in collaborative, interdisciplinary study and brings together students and faculty from different countries and backgrounds to address real-world challenges.

The third class of the MACS will start in October 2015. The programme attracts business executives, public officials, media representatives, academics, and civil society advocates from around the world. The MACS



offers a compact structure that allows participants to balance their career and studies. Seven intensive two-week modules take place in three-month intervals across two years. The modules examine corruption from the perspectives of economics, business, politics, and law, focusing on both enforcement and prevention.

Graduation from the MACS programme offers advanced career opportunities in such fields as compliance, internal oversight, law enforcement, investigative journalism, academia, finance, and international affairs. Our long-standing emphasis on innovation and focus on areas in demand ensure the competitiveness of our graduates after they leave campus.

# PROCUREMENT ANTI-CORRUPTION TRAINING SOLID PROGRAMME

As the summer holidays draw to a close, we invite you to join us for the third edition of our Procurement in Anti-Corruption Training, and learn about the ingredients of building a sound anti-corruption strategy in public procurement.

The programme will take place from 24 August to 18 September, combining a one-week on-site training at the IACA campus (7 - 11 September) and distance learning in participants' home countries. Sessions will include team exercises which address key issues in



procurement and corruption, such as corruption during emergencies, electronic reverse auctions, corporate compliance, investigations, and conflict of interest. Students are challenged to explore an anti-corruption strategy and apply what they have learned in providing recommendations on how it can be implemented in their home countries.
